Please be advised that Givaudan cannot guarantee the total absence of allergens in the fragrance. Givaudan also cannot guarantee that the fragrance meets the requirement of the EU technical document on cosmetic claims (implemented July 1, 2019) which states that "The claim free from allergenic/sensitizing substances is not allowed" and "if a cosmetic product claims to be hypoallergenic, the presence of known allergens or allergen precursors should be totally avoided".

The concentrations given for these substances represent the most accurate information at the time of generating this document based on intentionally added raw materials at the time of the manufacturing process and according to the EU Cosmetic Products Regulation (EC) No. 1223/2009.

Givaudan has a continuous analytical program in place to ensure a consistent data set at raw material level. These data have been consolidated based on the maximum observed analytical values at raw material level.

Our analytical data have been generated using a patented, high-confidence analytical method based on GCxGC-MS technology (Dutriez, Owen. Method of resolving allergens in perfume ingredients, WO2017207467A1, 2016), following the recommended technical features of the International Fragrance Association (IFRA) (Analytical method to quantify 57 suspected allergens (and isomers) in ready to inject fragrance materials by gas chromatography and mass spectrometry, 2016).

Our allergen data is maintained at the raw material maximum measured concentration level, and these are then computed to represent an aggregate allergen value of their presence in the fragrance oil. The fragrance mixture is not analyzed. By incorporating a max value approach of our analytical data Givaudan is intending to ensure stable allergens declarations over multiple deliveries avoiding any declaration change over the life of the fragrance product. It also minimizes the impact of slight variation from natural ingredients due to inherent variability of harvest conditions.

The concentration in this document corresponds to the maximum expected content in % weight in the indicated product. It does not represent any declaration relevant to finished product, that is responsibility of the customer.
